Minutes of the 69th Annual General Meeting

69th Annual General Meeting of Rajapur Saraswat Sangh, Mumbai, was held on September 29, 2019 at 10.30 a.m. at GSB Seva Mandal's Shree Guru Ganesh Prasad, Sion, Mumbai – 400 022. The meeting was presided over by Mr. Prabhakar D Borkar, the President of the Sangh. 110 members were present in the meeting. As there was no quorum at the scheduled time ie 10.00 a.m., the meeting had to be adjourned and the adjourned meeting was started at 10.30 a.m. as per the notice dated 25.08.2019, circulated amongst the members.

After the prayer(**Agenda No. 01**)from Mahila Mandal members, Ms. Pooja J Kamath, Hon. Secretary, welcomed the president, office bearers, members and guests present at the meeting and requested all the office bearers and committee members to occupy the seats on dais. She also read the notice dated 25.08.2019, circulated amongst the members and notice of the meeting published in the daily newspaper - Sunday Business Standard, issue dated 12.09.2019, for the information of the members present and briefed about the agenda of the meeting.

The following matters were transacted in the meeting:

Condolence (Agenda No. 02) : The. Hon. Secretary, Ms. Pooja J Kamath, read the names of the members who had passed away during the year. The gathering paid its tributes to the deceased members. The gathering also paid its tributes to the founder members of the Sangh & Mahila Mandal who have passed away. Mr P D Borkar, president, spoke about the contributions made by late Mr D K Patkar (Dombivli) and late Mr Shamrao K Nayak (Dombivli) to Sangh and Samaj, who passed away during the year.

As a token of respect to the departed souls, two minutes silence was observed and the following resolution was passed and adopted unanimously:

Resolution No: 01/AGM/2019:

“RESOLVED THAT the Rajapur Saraswat Sangh, Mumbai, deeply mourns the sad demise of its members who passed away during the year and prays the Almighty for the Eternal Peace of the departed souls and further prays the Almighty to give strength and courage to bear this irreparable loss caused to the family members of the deceased.”

Before the meeting started the Hon. Secretary, Ms. Pooja J Kamath, read out the mistakes appeared in the 68th Annual Report Book and requested the members to correct the same in their respective personal copies.

Agenda No. 3 : To read and confirm the minutes of the last AGM, held on September 30, 2018: The Hon. Secretary, Ms Pooja J Kamath, read the minutes of the 68th Annual General Meeting, held on September 30, 2018 and the same was approved unanimously and the following resolution was passed and adopted after it was proposed by Mr Vittal D Naik - Dombivli & seconded by Mr Sadanand Nayak, Mira Road.

Resolution No: 02/AGM/2019:

“RESOLVED THAT the minutes of the last annual general meeting, held on September 30, 2018, be and is hereby read, approved and adopted unanimously after it was proposed by Mr Vittal D Naik - Dombivli & seconded by Mr Sadanand Nayak, Mira Road.”

President informed that in the last AGM it was discussed and suggested that some of the clauses in the bye laws of the Sangha need to be amended and the Executive Committee was advised to look into this suggestion and place the proposed changes in this meeting for its approval. President said

that since the Sangha's Bye law was amended long back and it requires lot of amendments as per present requirement, particularly since the Sangha is going for redevelopment of its Parel premise. President further said that the Committee will place the proposal of amendment in the bye laws in the next AGM which was agreed and accepted unanimously.

Agenda No. 4 : Presentation and approval of Annual Report & Audited Statement of Accounts for the year ended March 31, 2019

Annual Report:

Hon. Secretary, Ms. Pooja J Kamath, placed "the annual report" for the year ended March 31, 2019 before the Annual General Meeting for its approval.

Mr Diwakar D Naik – Chembur asked the reason for not publishing the names of members' list in the Annual Report Book. It was replied by the president, Mr P D Borkar, that names of members' list was not published in the Annual Report Book as per the decision taken by the last Annual General Meeting. President further said that the details have been recorded in the minutes under Agenda No. 10 (any other matter) in page no : 06 of the 68th Annual Report Book.

The Annual Report, thereafter, was approved unanimously and the following resolution was passed and adopted after the same was proposed by Mr Gundu S. Nayak – Kalyan & seconded by Mr Mohandas S Sakhalkar – Kalyan and the following resolution was passed:

Resolution No: 03/AGM/2019:

"RESOLVED THAT the annual report for the year ended March 31, 2019 be and is hereby read, approved and adopted unanimously after the same was proposed by Mr Gundu S Nayak – Kalyan & seconded by Mr Mohandas S Sakhalkar -Kalyan".

Statement of Accounts:

The Hon Treasurer, Mr Nityanand P Prabhu, placed before the meeting the audited statement of accounts for the year ended 31st March 2019.

Mr Anand A Naik – Mulund said that Sangha's FDs should not be kept in any single bank in the interest of the Sangha. He was referring to the Sangha's FDs with NKGSB and Bharat Co-op. Bank. After discussion it was decided that FDs of the Sangha should be kept in different banks including Saraswat Bank, Shamrao Vittal Co. Op. Bank and nationalised banks. It was further decided that 30% of the amount be invested in nationalized banks. President assured that FDs will be withdrawn/encashed as per maturity dates and will be invested to other banks as decided.

Mr H S Kamath suggested that the details given in "Scholarship/Medical Aid distributed during the year 2018-19", the amount shown be either in ascending or descending order (Mr Kamath was referring to page 18 to 23 of annual report). Agreeing to his suggestion, President assured that the list will be published as suggested by Mr Kamath from next year onwards. President further said that names will, however, be continued as it is in "Schedule A" of the Final Accounts as the same is prepared by the Statutory Auditors as per date of its start.

As there were no other clarifications sought from any one, audited statement of accounts for the year ended 31st March 2019, was approved unanimously after the same was proposed by Mr Ashok Patkar & seconded by Vittal D Naik – Dombivli & Mr Sukumar Nayak - Dombivli.”

Resolution No: 04/AGM/2019:

“RESOLVED THAT the audited Statement of Accounts for the year ended March 31, 2019 be and are hereby approved and adopted unanimously after the same was proposed by Mr Ashok Patkar & seconded by Vittal D Naik– Dombivli & Mr Sukumar Nayak - Dombivli.”

Agenda No. 5 : Presentation and Approval of Budget for the year 2019 - 2020:

Hon Secretary, Ms. Pooja J Kamath, presented the budget for the year 2019–2020, a copy of which had already been submitted to the office of the Charity Commissioner as per statutory requirement. After discussion the General Body authorised the Executive Committee to :

1. spend towards urgent/major repairs of the building premises;
2. spend towards any minor repairs to the office premises and up-keep of the building;
3. spend towards donations in deserving/emergency cases for social, religious and cultural activities;
4. spend towards the objects of the sangh; &
5. spend towards expenses required in respect of matters related to redevelopment/reconstruction of the land/property of the Sangh.

The budget for the year 2019-2020 was unanimously approved after the same was proposed by Mr Raghunath N Naik – Dombivili & seconded by Mr H S Kamath – Deonar & Mr Mohandas S Sakhalkar - Kalyan.”

Resolution No: 05/AGM/2019:

“RESOLVED THAT the Budget for the year 2019-2020 be and is hereby approved and adopted unanimously after the same was proposed by Mr Raghunath N Naik – Dombivili & seconded by Mr H S Kamath – Deonar & Mr Mohandas S Sakhalkar - Kalyan.” and further it was also Resolved that the Executive Committee be and is hereby authorized to spend towards urgent/major repairs/renovation, repairs to the office premises and up-keep of the building, donations in deserving /emergency cases for social, religious and cultural activities, towards object of the Sangh & towards expenses required in respect of matters related to redevelopment/reconstruction of the land/property of the Sangh.”

Agenda No. 6 : Appointment of Internal Auditors for the year 2019-2020:

As no names were proposed and seconded in the meeting for the Internal Auditor/s for the year 2019-2020, it was unanimously decided to authorize the Executive Committee to appoint Internal Auditor for the year 2019-2020. The following resolution was passed and adopted:

“RESOLVED THAT a decision be and is hereby taken to authorize the Executive Committee to appoint Internal Auditor/s for the year 2019 - 2020.”

Agenda No. 7 : Appointment of Statutory Auditors for the year 2019-2020:

M/s S. Sadashiv & Co. were appointed as Statutory Auditors for the year 2019 – 2020 after the same was proposed by Mr Ashok Patkar – Dombivli & seconded by Mr Sadanand Nayak – Mira

Road and the Executive Committee was authorised to discuss and decide about their fee/remuneration and the following resolution was passed and adopted :

Resolution No: 07/AGM/2019: “RESOLVED THAT M/s S. Sadashiv & Co., Chartered Accountants, be and are hereby appointed as Statutory Auditors for the year 2019 – 2020 and RESOLVED further that the Executive Committee be and is hereby authorized to fix their fee/remuneration after the same was proposed by Mr Ashok Patkar – Dombivli & seconded by Mr Sadanand Nayak – Mira Road.”

Agenda No. 8 : To brief the Status of the proposal of redevelopment of Sangh's Parel building:

President, Mr P D Borkar, said that there is no much progress in the “Redevelopment” issue as the tenants have not yet given their consent and coming out with new demands each time of the meeting. He said that Sangha and Redeveloper are trying their best to take the consent of the tenants and hoped that they will succeed in obtaining the same at the earliest by having further mutual meetings and discussions. Mr Ramesh Prabhu – Kandivli said that the president had assured the same thing in the last AGM also and suggested that committee should try to get the consent letters from the tenants through redeveloper at the earliest by mutual discussions.

Agenda No. 9 : Election of 25 members (area-wise) to the Executive Committee for two years (ie 2019-20 & 2020-21):

The president asked the members to propose and second the names for the new committee members area-wise for the year 2019-20 & 2020-21 (2 years). President said that new young members should come forward and become the committee members. It was unanimously suggested that the present existing committee should continue for another two years. Mr Nityanand P Prabhu, Mr Vithal P Wagle, Ms. Latha G Nayak and Ms. Shanta S Nayak expressed their unwillingness to continue as Executive Committee members due to their personal reasons. Mr P D Borkar informed that Capt. M Radhakrishna Borkar & Mr. Suresh P Nayak (not present in the meeting) also had informed him that they will not be able to continue as Executive Committee members. Mr. Anand A Naik- Mulund, Mr Sadanand S Prabhu – Bhandup, Ms. Jyoti V Naik - Dombivli, Ms. Manisha P Nayak – Panvel, Mr. Mohandas S. Sakhalkar – Kalyan and Mr Satish N Patkar – Vashi expressed their willingness & to become committee members. As there were no other names proposed, it was proposed by the members present in the meeting that the other existing committee members be continued for the next two years. The president informed that Ms. Smita V Patkar and Mr. K Narayan Nayak – Chembur are out of country but are ready to continue as committee member if no other members are elected in their places which was agreed by the AGM. Agenda No. 10 : consideration of letters, if any, and to take appropriate decision : President informed that the Sangh has not received any letter/s from members to place before the AGM.

Agenda No. 11 / Agenda No. 12: Any other matter with the permissionof the chair/ members' speech:

Mr H S Kamath, Deonar: Congratulated the newly elected committee members and wished the committee all the best. Suggested that a strong Medical Fund need to be created so that the Sangh will be able to help the needy members financially through this Medical Fund. Suggested that the Census work should be completed at the earliest with all the required details like contact numbers of members etc. He opined that at least in the general body meetings, bouffet lunch has to be discouraged and “Saha Pankti Bojana” has to be encouraged wherein all the members will enjoy the lunch together. Also, suggested to update the Sangha's website regularly which will enable the members to know more about the activities of the Sangh.

Mr Ramesh Prabhu – Kandivli: Expressed his concern over the poor attendance in the AGM meetings of the Sangh. Said that more and more members should participate in the meetings and thereby contribute their best towards the development of the Sangh. He also expressed concern over the poor attendance & participation from the youths and suggested that the Sangha should think seriously about this and should do something that encourages the youth members to participate in the meetings. Suggested that Sangh should purchase of plot in the western railway area to construct one community hall. Suggested that a separate Shradhanjali Sabha (Prayer Meeting) should be organized by the Sangh whenever a person who contributed a lot to Samaj and Sangha passes away. Congratulated the newly elected committee members and wished the committee all the best and suggested that the committee should work in a very transparent manner so that no doubt will arise about the working and functioning of the Sangh.

Mr M V Prabhu – Borivali : Informed the meeting that a statutory training session for the members of the Shree Durgaparameshwari Co-op. Credit Society Ltd, Parel, Mumbai has been organized in the afternoon on September 29, 2019 from 2.30 pm onwards at GSB Hall, Sion, and requested the members to attend and participate in the training programme. Thanked the Sangha for its co-operation in holding this training session.

Mr P R Ravishankar : Thanked for electing him for another term. Hoped that the committee formed on the starting day of “Navrathri” (today) will also be blessed by Nava Durgas and the committee will succeed in achieving its goals. Supported the suggestion of Mr H S Kamath that a

strong Medical Fund to help the needy financially has to be created. Requested the members and other community samsthas to attend the functions organized by other community samsthas and further said that we will be able to learn and observe a lot by attending these functions/programmes. He invited the members for the programme "Bombaid Tulu Naad" organized by Kala Jagattu – Mumbai, to be held on 7, 8 & 9.10.2019 at Kandivali – West, Mumbai. Thanked Sangha for organizing Gauravarpan Satkar programme to Swamiji on the occasion of his completion of 25 years of his shishya sweekara on October 02, 2019 at Walukeshwar Math and said that members from Dahanu will be present during the occasion through Rajapur Saraswat Samaj – Dahanu. He appealed all our other samsthas and members to join the celebration. He thanked Mr P D Borkar for taking lead in organizing this programme. He spoke in detail and stressed the importance of having swamiji / Guru for the progress of any community. Requested the members, particularly the youth, to talk in our mother tongue Konkani without any inferior complexity. Wishing good luck to the Sangha, thanked Sangh for giving him a chance to speak.

President's Speech :

President, Mr Prabhakar D Borkar, in his presidential speech thanked the members for electing the new committee and assured that all the committee members will work for the betterment/progress of the Sangha in a very transparent manner. He said that the committee will look into all the suggestions put forward by the members in the General Body meeting and work out solutions wherever possible. Expressed concern over the poor attendance of members /youths in the General Body Meeting. Said that this year Sangh has uploaded the entire version of 69th annual report book in the sangha's website. He said that it is Sangh's wish to purchase a clear titled vacant plot in the western railway area and to construct a hall thereafter. He said that around 14 plots have been visited and seen so far in the western railway area but could not go ahead as the plots were not suitable for purchase and construct the hall. He requested the members, specifically those staying in the western railway area, to help the sangha in identifying a good, clear titled plot. Requested the members to encourage membership drive and contribute towards various Education, Medical and Sandhya Suraksha Nidhi funds of the Sangha. He appreciated the work done by Mahila Mandal and Yuva Vrinda in spite of their busy schedule. Assured that the committee will try to finish the Census work before next AGM. The importance of "Guru-bhakti" was highlighted by the president and he called upon the members to offer/donate "Guru Kanika" every year to the Kaivalya Matt. He briefed about the proposed programme (Navachandi Hawan & Gauravarpan Satkar to Swamiji on the occasion of his completion of 25 years of his shishya sweekara) that will be organized on October 02, 2019 at Walukeshwar Math by Sangha and other samaj samsthas of Mumbai/Pune and requested the members to be present during the occasion. He requested the members to donate towards the "Swarna Peeta" that was offered by the samaj people to Bhavani Shankar, aradhyा diety of Kavle Math, Goa. President announced that there is a proposal from a senior member of the samaj that he is ready to donate/sponsor some amount to a needy senior male person who do not have any one to look after and do not have any source of income and who is not looked after by any one. He requested the members to bring it to the notice of the committee members in case they come across such person so that the application can be forwarded to the concerned donor for the financial aid.

The Annual General Meeting was concluded with vote of thanks by the Hon. Secretary followed by national anthem.
